#### The product is not designed for customers who:

- Intend to reside in the property permanently.
- Want to let the property on a long-term lease.
- Are severely credit impaired.
- Want to fix their monthly costs for a defined period.
- Want to make more than 5% penalty-free overpayments during the product term.
- Do not meet our lending or property criteria.

#### Intermediary distribution is via:

- Networks and their appointed representatives.
- Mortgage Clubs.

All intermediaries must be registered with us.

### 4. Customers with characteristics of vulnerability

The product is designed for furnished holiday let borrowers which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.
